### REGIONAL MEETING UPDATE

#### JULY 27, 2006 REGIONAL MEETING

Dr. Owen Richards, President of Quantic Regulatory Services, made a presentation entitled 'To Be or Not to Be', 'That is the Question' in relation to consultancy-at Mogul Restaurant in Morris Town, NJ. The meeting was well attended. Dr. Richards provided a brief description of the structure of one or more of the following list of skill sets: Laboratory (Micro/Chemistry), Validation (Process/Methods), Processing, Cleaning, Packaging/Labeling, Warehousing/Distribution, Regulatory filings, Compliance (cGMP), Quality Assurance, Clinical Development, Clinical Studies (GCPs), Pharmacovigilance, Leadership and Project Management.

Consultants are assigned, based on their skill sets, to review client's operations in depth and provide appropriate advice and remedial recommendations to the client. This may include mentoring. Quantic consultants do not get involved manually in the operations of the client company. There is a 'fire-wall' between consultants providing advice and recommendations and those assigned to independent auditing of the clients operation to avoid collusion between the two functions.

In the last few years several pharmaceutical companies have come under 'Court Consent Decrees'. Also many companies are seeking expert assistance to avoid coming to that stage. This has provided immense consultancy opportunities to individuals and small and large consultancy companies.

The assignments include prospective quality systems analysis and development, remediation of specific technical issues, auditing of sites, products, processes, drafting policies and procedures.

Dr. Richards warned the aspiring consultants on unpredictability and immense commitment needed in the field of consultancy. In his opinion it cannot be compared to a steady job with a reputable company and is best suited for those with sufficient financial security. The commitment required from consultants may cause loss of flexibility in personal life, will require travel and having to work weeks and months away from family.

### AAPS ELECTION RESULTS

The first regional meeting of the AAiPS Metro DC Chapter was held on June 10, 2006 at Mirch Masala Restaurant in Kentlands. About 30 members attended the meeting. **Novavax, Inc., Malvern, PA.**

Dr. Rahul Singhvi was appointed President and CEO of Novavax in August, 2005. He took over at a time when the company was on shaky footing. Novavax was a specialty pharmaceutical company focused on women's health with a 100-person sales force promoting its FDA-approved Estrasorb®, a transdermal estrogen replacement therapy.

Since taking over in 2005, Dr. Singhvi has redirected resources to the company's long neglected Biologics group, enabling the transformation of Novavax into a cutting edge, particulate vaccine biotech company. Its Avian and Seasonal Flu vaccine

Dr. Singhvi joined Novavax in April, 2004 as Vice President, Pharmaceutical Development and Manufacturing Operations and was appointed Senior Vice President and Chief Operating Officer in April, 2005. ## INDIA NEWS

### Suven-Lilly Collaboration

Suven Life Sciences Limited announced that it has signed an agreement with Eli Lilly and Company to collaborate on the pre-clinical research in the therapeutic area of central nervous system disorders.

### Mylan Takes Over Matrix

Mylan has agreed to spend \$736 million to acquire a controlling stake in Matrix, an Indian manufacturer of APIs and solid oral dosage forms. Matrix is the second largest API manufacturer when it comes to either the number of DMF's under development or developed

### India Topping Contract Research Business

With 15 prominent CRO's in the country, India's CRO business values at about \$100 -120 million and is growing at 20-25% per year. The second and third place was held by Italy (\$60-70m) and Spain (\$25-33m), respectively.

### India to overhaul drug price policy

India is planning to change its pharmaceutical price policy by setting up ceiling prices for about 250 drugs and is revising the list of drugs which can be included on the existing cost-based price control system. Under the proposed ceiling price-based plan, the weighted average price of three to five leading brands, will act as the ceiling price for the maximum retail price. The pharmaceutical industry is expected to meet India's Chemicals and Fertilizers Minister to discuss some of the proposals. The government may also consider exempting anticancer and antiretroviral drugs from the 15% customs duties applicable to medicines.

### DSM and Lupin enter into alliance on cephalosporins

DSM Anti-infectives India and Lupin have entered into an agreement to supply and market cephalosporins. Lupin expects to supply the active pharmaceutical ingredient for a range of products to DSM under the alliance. Both companies expect to strengthen their positions in this segment through enhanced utilization of existing resources and improved market access.

### Ranbaxy launches Italian operation

Ranbaxy Laboratories has set up a wholly owned subsidiary, Ranbaxy Italia, in Milan and expects to use the "organic" growth route to develop its presence there. In the past, the company has used acquisitions to jump-start operations in markets such as France. It plans to introduce generic medicines in Italy by early next year. Ranbaxy has now consolidated

its presence in the top five European pharmaceutical markets and is also present in 21 of the 25 EU countries. The \$16.5 billion Italian pharmaceutical market is the fourth largest in Europe after Germany, the UK and France.

The 58th Indian Pharmaceutical Congress to be held in Mumbai in December 2006 is going to showcase strengths of Indian pharmaceutical industry in the areas of human, material and intellectual resources.

### OBITURARY

It is with deep regret we report the loss of four leading scientists and educators of Pharmacy in the US:

**Dr. Arthur Mlodozeneic-** Until his death, he served as Vice President and CSO of PharmQuest Corporation in Mountain View and CSO for Conformia Software, Inc. in Redwood City. He worked in companies such as Upjohn, Hoffman La Roche and Merck in various capacities. He was also professor of Pharmaceutics at the University of California.

**Dr. Joseph R. Robinson-** Dr. Robinson received his Ph.D. from the University of Wisconsin-Madison in 1966. He became a professor at the UW-Madison in 1966 and retired from there in July 2005. He received numerous other prestigious awards. He was a founder of AAPS.

**Dr. Milo Gibaldi-** Dr. Gibaldi received his Ph.D. from Columbia University. He can be considered one of the fathers of Pharmacokinetics. He was one of the youngest Chairman of the Department of Pharmaceutics at State University of NY at Buffalo. He was a great teacher and mentor. He was also the Dean of School of Pharmacy at University of Washington in Seattle, and a contributory editor for AAPS News Magazine.

**Dr. Joe Schwartz-** Professor of Pharmaceutics at Philadelphia College of Pharmacy and Science passed away in September 2006 after prolonged illness. Dr. Schwartz was an authority on solid dosage forms and had received many awards including the AAiPS fellow award.

A multiparticulate drug delivery system was studied in which the drug release of a model drug theophylline could be modulated by interactions of ammonio methacrylate polymer and anions. The system consisted of a EUDRAGIT NE coated anionic core, layered with drug and further layered with EUDRAGIT RS. The effects of different anions like chloride, succinate, citrate, and acetate as well as the thickness of the polymer layers on the in vitro drug release were studied. It was seen that succinate and acetate anions had permeability enhancing effects and citrate and chloride anions had permeability retarding effects on the polymer.

Effective interstitial transport of particles is necessary for injected drug/diagnostic agents to reach the intended target; however, quantitative methods to estimate such transport parameters are lacking. Fluorescently labeled macromolecules and particles are co-infused with a reference solute at constant infusion pressure intra-dermally into the mouse tail tip, and their relative convection coefficients are determined from spatial and temporal interstitial concentration profiles. To demonstrate sensitivity and usefulness of this model, the effects of size, shape, and charge on interstitial convection were compared. Data showed that size exclusion (within a specific size range) dominates molecular convection, while mechanical hindrance slows larger molecules and nanoparticles; proteins convect slower than linear molecules of equal molecular weight, and negative surface charges increase convection through matrix repulsion.

Economic impact of workplace productivity losses due to allergic rhinitis compared with select medical conditions in the United States from an employer perspective. The Work Productivity Short Inventory was used to assess the impact of a predefined group of health conditions on workplace productivity for the previous 12 months. A total of 8267 US employees at 47 employer locations volunteered to

participate in health/wellness screenings. Both absenteeism and presenteeism (lost productivity while at work) were recorded. Allergic rhinitis was the most prevalent of the selected conditions; 55% of employees reported experiencing allergic rhinitis symptoms for an average of 52.5 days, were absent 3.6 days per year due to the condition, and were unproductive 2.3 h per workday when experiencing symptoms. The mean total productivity (absenteeism + presenteeism) losses per employee per year were 593 US dollars for allergic rhinitis, 518 US dollars for high stress, 277 US dollars for migraine, 273 US dollars for depression, 269 US dollars for arthritis/rheumatism, 248 US dollars for anxiety disorder, 181 US dollars for respiratory infections, 105 US dollars for hypertension, 95 US dollars for diabetes, 85 US dollars for asthma, and 40 US dollars for coronary heart disease.
